DISCLOSABLE PECUNIARY INTERESTS

- 1. A Member, present at a meeting of the Authority, or any committee, sub-committee, joint committee or joint sub-committee of the Authority, with a Disclosable Pecuniary Interest (DPI) in any matter to be considered or being considered at a meeting:
 - must not participate in any discussion of the matter at the meeting;
 - must not participate in any vote taken on the matter at the meeting;
 - must disclose the interest to the meeting, whether registered or not, subject to the provisions of section 32 of the Localism Act 2011;
 - if the interest is not registered and is not the subject of a pending notification, must notify the Monitoring Officer of the interest within 28 days;
 - must leave the room while any discussion or voting takes place.
- 2. A DPI is an interest of a Member or their partner (which means spouse or civil partner, a person with whom they are living as husband or wife, or a person with whom they are living as if they were civil partners) within the descriptions as defined in the Localism Act 2011.
- 3. The Authority may grant a Member dispensation, but only in limited circumstances, to enable him/her to participate and vote on a matter in which they have a DPI.
- 4. It is a criminal offence to:
 - fail to disclose a disclosable pecuniary interest at a meeting if it is not on the register;
 - fail to notify the Monitoring Officer, within 28 days, of a DPI that is not on the register that a Member disclosed to a meeting;
 - participate in any discussion or vote on a matter in which a Member has a DPI;
 - knowingly or recklessly provide information that is false or misleading in notifying the Monitoring Officer of a DPI or in disclosing such interest to a meeting.

(Note: The criminal penalties available to a court are to impose a

fine not exceeding level 5 on the standard scale and disqualification from being a councillor for up to 5 years.)

303 APOLOGIES

Apologies for absence were submitted from Councillors D Abbott, S Cousins and Mrs D Hollebon. It was noted that Councillors D Oldridge and R Standley were substituting for Councillors S Cousins and Mrs D Hollebon

respectively.

304 MINUTES – 14 JUNE 2016

<u>RESOLVED</u> – that the Minutes of the meeting held on 14 June 2016 be confirmed as a correct record and signed by the Chairman.

305 CHAIRMAN'S ANNOUNCEMENTS

The Chairman summarised what was discussed at the last meeting of the Scrutiny Chairmen and Vice-Chairmen and highlighted the distinction between Members being given information and Members carrying out scrutiny. The Chairman encouraged Committee Members to be proactive in scrutinising reports and getting involved. She noted that any topics which were assessed to be 'information seeking' rather than scrutiny could then be put forward for either a future member briefing/training event or, if suitable, as a written reply/article in the Members Information Bulletin.

Finally, she referred to the Panshanger Park Run plus a number of other projects that had been awarded a grant by the East Herts Health and Wellbeing Community Fund.

306 PLANNING AND HEALTH AND WELLBEING

The Scrutiny Officer and the Chairman submitted a report which gave Members the opportunity to gain evidence regarding planning and health and wellbeing at a strategic level and which assured that the wider public health agenda was being appropriately integrated prior to the adoption of the District Plan in 2017.

The Head of Planning and Building Control introduced the report and summarised the key issues in respect of the current position regarding planning and health and wellbeing. He reminded Members that the Authority was undertaking the penultimate stages of the District Plan preparation process.

The Chairman of the Development Management

Committee, Councillor T Page, referred to negotiations that occurred before applications reached the Committee. He commented on the Hertfordshire County Council (HCC) toolkit for Section 106 funding and referred to the importance of information regarding where this money should be spent in order to maximise community benefit.

Councillor P Ballam welcomed the comments that had been made and emphasised the importance of a more efficient system regarding Section 106 funding. Councillor T Page confirmed that Section 106 funding was being monitored closely by a Director.

Members raised a number of relevant issues and Officers and the Executive Member for Development Management and Council Support responded to queries and questions from the Committee. Members received the report and endorsed the recommendations now detailed.

<u>RESOLVED</u> – that (A) Officers be requested to further explore the service's contribution to the wider public health agenda; and

(B) Officers explore the feasibility of HCC public health being asked to comment on an interim basis on relevant planning applications at a useful point in the development management process prior to the adoption of the proposed District Plan.

307 OPPORTUNITIES TO SUPPORT INDEPENDENT LIVING ARISING FROM THE PROPOSED HOME IMPROVEMENT AGENCY

The Executive Member for Health and Wellbeing submitted a report updating Members on the ongoing project to develop a Hertfordshire Home Improvement Agency (HIA) to help elderly and vulnerable persons to remain living independently at home.

The Head of Housing and Health invited Members to support East Herts Council becoming a partner in the Hertfordshire HIA. The Committee was also invited to

propose innovative ideas to enhance service provision. Members were reminded of the background to the HIA and the work that had been completed to date. The Head summarised a number of other relevant issues from the report and encouraged Members to email him with any ideas they had following the meeting

The Chairman commented on the time it could take for the completion of some home adaptations thus delaying discharge from hospital. The Head of Service stated that the current process, including means testing for all works, however small, could lead to the whole process taking in excess of 6 months and a new system for low cost works without means testing could take just a few weeks.

Councillors J Jones and M Stevenson commented on the excellence of the changes referred to by the Head of Housing and Health. The Head of Service advised that the Executive had confirmed East Herts Council's commitment in a shared service with a view to this going live as part of the Hertfordshire HIA by September 2017.

The Head of Service confirmed to Councillor P Ballam that the proposals should ensure that the needs of Hertfordshire residents were not delayed. He also responded to a query from Councillor D Oldridge by stating that all participating Hertfordshire Authorities would be working closely together to ensure residents got what they needed.

Councillor M Stevenson noted that in the long term she would welcome the HIA looking at linking to a wider range of services including telecare. The Head of Service noted this suggestion.

Members supported the recommendations now detailed.

<u>RESOLVED</u> – that (A) the proposal that East Herts Council becomes a partner in the Hertfordshire Home Improvement Agency (HIA) be supported;

(B) the opportunities to enhance service provision

by virtue of the HIA proposal and funding changes be supported; and

(C) a pilot adaptations service of non-means tested, fast-tracked, low cost works be evaluated with a view to whether these works could be completed in days rather than weeks.

308 UPDATE AND MINUTES FROM HERTFORDSHIRE COUNTY COUNCIL HEALTH SCRUTINY COMMITTEE

The Chairman reported that she had attended the meetings of Hertfordshire County Council's Health Scrutiny Committee and there was nothing specific to report back. The Minutes of Hertfordshire County Council's Health Scrutiny Committee meetings on 12 July 2016 were submitted for information. The Committee noted the Minutes.

RESOLVED – that the Minutes be noted.

309 SCRUTINY WORK PROGRAMME

The Chairman of the Health and Wellbeing Scrutiny Committee submitted a report reviewing the Committee's work programme for 2016/17. The Scrutiny Officer advised that the report on Air Quality Management areas would be submitted to the meeting on 14 March 2017 instead of 15 November 2016.

The Scrutiny Officer advised that this would result in a number of substantial items for the March 2017 meeting. The Environmental Health Promotion Officer said his report on the East Herts Health and Wellbeing Funded projects could be moved to November 2016. He asked the Committee if they still wished to receive this report in light of the change of status of the Committee from a Panel. Members confirmed that they did and that they would be happy to receive the report in November 2016. It was noted that the Chairman and Scrutiny Officer would further review the agenda for the March 2017 meeting.

The Scrutiny Officer asked who would be invited to update on the Mental Health Day. It was confirmed that the Council's Member Champion on Mental Health, Councillor P Moore, would be invited to provide a report in March 2017. The Chairman encouraged Members to attend East Herts Council's Mental Health day on 9 October 2016 at Hertford Theatre. Members approved the work programme, as now amended.

Purpose/Summary of Report

• To update the Committee on the progress and evaluation outcomes of the East Herts Community Health and Wellbeing Fund Phase One projects.

RECOMMENDATIONS FOR HEALTH AND WELLBEING SCRUTINY COMMITTEE That:

The effectiveness of the projects be scrutinised and best (A) practice shared.

1.0 **Background**

- 1.1 In 2014, the Director of Public Health for Hertfordshire provided the District and Borough Councils in Hertfordshire with £2 million pounds to help address local health inequalities. The money was released in two phases which equates to £100,000 for each phase for every District and Borough Council. It was originally intended that the District Offer would span a two year delivery period. Due to the logistical planning aspects and the diversity of projects delivered this has now been extended to a four year period.
- 1.2 East Herts Council has worked with Hertfordshire County Council's (HCC) Public Health team throughout the project to develop, assess and deliver projects in East Herts. Part of the formal agreement between HCC Public Health and East Herts has

included a signed memorandum of understanding, regular progress meetings and quarterly reports presented to the Public Health Board.

2.0 Report

- 2.1 The Public Health Partnership Fund (formally the District Offer) is known within East Herts as the East Herts Community Health and Wellbeing Fund to enable easier promotion of the projects to East Herts residents.
- 2.2 The East Herts Health and Wellbeing Partnership Group along with suggestions made by Health and Wellbeing Scrutiny Committee (HWSC) and wider members, approached various organisations who were asked to submit ideas. The development of these ideas were further supported by the Environmental Health Promotion Officer.
- 2.3 The bids were assessed against the strategic vision and fund criteria, based upon the East Herts Health and Wellbeing Strategy priorities 2013-2018. This was completed by an assessment panel made up of the Executive Member for Health and Wellbeing and officer representation.
- 2.4 14 bids in total were assessed in January 2015, with nine being given the go ahead for support and a remaining five requiring further research and recommendations before a decision could be reached. The second round looking at the remaining five bids were made through email assessments following receipt of additional information.
- 2.5 Of the 14 supported bids, the various projects supported three themes: Lifestyle, Physical Activity and Healthy Living.
- 2.6 In order for organisations to receive the funding allocated to them a set of objective measures and outcomes were agreed upon. Delivery of these outcomes in a template report format were part of the funding agreement signed by all organisations receiving the awarded monies.
- 2.7 In addition to the reporting outcomes described in 2.6 above the HWSC Chairman also engaged members of the Committee in visiting a number of the projects to learn more about the benefits the clients received through taking part. The summary of these evaluation visits is contained in **Essential Reference Paper B**.

- 2.8 The summary details of each project and their reported evaluation outcomes are also contained in **Essential Reference Paper B**.
- 2.9 HWSC Members are asked to scrutinise the reported evaluation measures and invited to ask questions about the projects from the information presented to them.
- 3.0 Report Summary
- 3.1 The funding from HCC has already led to a number of benefits to the residents of East Herts some of the key benefits which the Council has noted so far include:
 - Partnership connections with supported organisations have been strengthened.
 - A number of the projects have worked with organisations that have targeted vulnerable clients, demonstrating improvement in their health outcomes.
 - The small grants programme has worked well delivering 10 small projects improving mental health and physical activity outcomes for school communities and clients of smaller voluntary organisations.
 - The success of the East Herts Community Health and Wellbeing Fund Phase One projects have been reported to HCC Public Health Board in June 2016 and also to HCC Health and Wellbeing Board in October 2016, with the aim of exploring the potential for wider rollout of successful projects and benefit from the shared learning with other Districts and Boroughs across Hertfordshire.



3.Forever Active East Herts (CSAF) –increasing physical activity levels for 50+ age group	- To increase number sedentary people aged 50 to 75 who participate at least once a week in sports and physical activity To increase participant confidence, reduce barriers and promote increase in trained volunteer coaches.	 Forever Active East Herts was launched in November 2015 with a Come and Try event at Wodson Park in Ware. The event attracted approximately 200 individuals, an excellent start to the project. As the project is a concept that has been developed in partnership to obtain external funding from Sport England it has been quite different from supporting a pre-existing organisation. As a result there have been a number of administration and project management steps required. This has involved setting up the project to run efficiently, safely and sustainably, as well as identifying community delivery partners who are interested in hosting sports and physical activity classes. There has been good progress in the last year and Sport England is satisfied with the figures submitted in July 2016. A total of 648 individuals attended at least 1 class with a target of 854 by end of December 2016. 4,105 overall attendances have occurred with a target of 8,656 by the end of December 2016. Up until now, the project has worked with 20 community partners (including churches, sports clubs, and village halls) with more expressing interest each week. Two Come and Try free taster events have been delivered with Buntingford attracting 59 individuals and Ware around 150 individuals. It is recognised that it is challenging to reach sedentary individuals rather than those that are already active. The project coordinator and East Herts Council communications team have been working together on a targeted marketing campaign using behavioural change theory. 	£10,000

Our initial plan was to mentor each young person just 6 weeks; however the root of these problems was more complex than first thought. In order to make the most impact in their lives as possible the original batch of young people who volunteered with us were mentored throughout the year, in line with other mentoring programmes which work on a yearly basis.

We built up a toolkit of items that were funded to enable each client to benefit from these items free of charge to fully support them. These items included a clock, whiteboard, signs and stronger light bulbs each of which supported the Dementia Friendly Homes audit. Each of these items were chosen specifically for the positive effects they could bring to the home and the person living with Dementia and were relatively low cost. We are actively involved in the Ageing well group for East Herts to continue joint working between services and tailoring new services to best support people living with Dementia. We gave many presentations on Dementia friendly environments, including one at Braughing Parish council for 50 people to broaden the outreach of the project to more rural areas.

Five residents (36%) said they felt their physical health had improved and nine (64%) saw improvements in their mental wellbeing. Finally, six (43%) said the visit increased their ability or desire to take exercise. - Six student groups measured Nitrogen Dioxide using (NO2) Diffusion Tubes over a two-week exposure period
- Student groups developed campaigns seeking to engage parents, teachers, peers and local primary schools around air quality issues. This included the creation of visual media by students including animations and posters
- Redevelopment of the Cleaner Air 4 Secondary Schools Toolkit with 'teacher-friendly' resources, content and activities.

Travel behaviour achievements:

- The number of students wishing to travel to school by walking or cycling increased by 5%.
- The number of students wishing to travel to school by car decreased by 22%.
- Prior to the project, 67% (17) of students claimed to know how their actions affected pollution, compared to 92% (24) afterwards.
- Prior to the project, 41% (12) of students claimed to be aware of the actions they can take to reduce their exposure to air pollution, compared to 85% (22) afterwards.
- Prior to the project, 66% (19) of students claimed to be concerned about the health impact of air pollution, compared to 81% (21) afterwards.

- When the project first began, the residents were unwilling and reluctant to be involved – at all. Many of the sessions found the teacher cooking by herself, and the residents only arrived once the food was ready to eat. During this time, the teacher was able to chat with them and start building a relationship with them.
- The next set of sessions saw one or two residents begin to venture in and participate a little in the actual cooking. A new worker also helped with Resident engagement with worker drawing further interest to the class.
- By the end of the second set of sessions, the Lounge was often very busy during the course with residents socialising, playing pool, and participating in the course. A handful of residents were particularly interested in the cooking and actively participated in that aspect every single session from start to finish, even suggesting meals they would like to learn to cook and sourcing cheap and healthful ingredients.
- Not only did the residents gain enough confidence to take an active role in the cooking class, being in the Lounge together socially once a week sparked in them a desire for more. This inspired the creation of a weekly "Art Club" that the residents also attended, the re-convening of the pool team, and more cooking-related activities. "It brought residents together," was one comment we received regarding the cooking course.

A successful session and very worthwhile doing. Another visit by the one of the Councillors in the paired team was planned to see a similar session at Hartham.
8. Herts Mind Network – Exercise to Wellbeing	Feedback from the two Councillors who visited Herts Mind Network (HMN) was as follows. It was a very gratifying experience. HMN were obviously doing a useful job filling in a gap in caring for residents and were making good progress in organising the walks. At this initial stage it was noted HMN were

	experiencing some difficulty in having people referred to them and it was apparent that all contact avenues should be considered.
	A discussion between Councillors and HMN took place on how the referral process may be helped and it was suggested more direct contact with the GP surgeries through scheduled visits and links with wider health groups could be beneficial.
A variety of other projects listed above were visited by combined teams of Councillors on the Scrutiny Committee.	The overall feedback was that the Councillors enjoyed the experience of visiting the projects, learned a lot about the organisation and clients and were pleased to see the health and wellbeing benefits that the East Herts Community and Wellbeing Fund had enabled.
