- (H) the number of Executive Members to be appointed to the Executive be (TBA), plus the Leader and Deputy Leader of the Council,
- (I) the Council's Standards Committee be appointed for the ensuing civic year consisting of two independent Members (previously appointed to serve a four year term of office), three District Councillors (one from each political party with five or more Members), one Town Council Member, one Parish Council Member and the following individuals be appointed thereto:

(J) the programme of Council meetings, as previously agreed, be confirmed.

- (K) the action to be taken by the Assistant Director (Law and Control), in consultation with the Leader, under delegated authority, concerning the appointment of representatives to outside bodies, be noted, and
- (L) the Community Voice bodies be retained.

1.0 Background

- 1.1 The Council previously adopted a new model for political management in accordance with the requirements of the Local Government Act 2000.
- 1.2 The report has been prepared on the basis that the Council will continue with its existing political management model and constitution, subject to a number of amendments as detailed below.
- 2.0 Contributions to the Council's Corporate Objectives
- 2.1 The proposals set out in this report will support all of the Council's corporate objectives.
- 3.0 <u>Scrutiny Committees, Regulatory Committees and Joint Committee</u>
- 3.1 It is proposed to retain the arrangements introduced for 2003/04 for the ensuring Civic Year. Accordingly, three scrutiny committees will be reconstituted. One of these committees will focus on performance and one on policy. The remaining committee, the Call-In Scrutiny Committee, will be principally charged with reviewing decisions of the Executive referred to it by Members.
- 3.2 The scrutiny committees will comprise the following number of Members:

Performance Scrutiny	16

Call-In Scrutiny	12

3.3 The Development Control Committee (comprising 25 Members) and the Licensing Committee (comprising 17 Members) will retain their existing terms of reference. It should be noted, however, that with the imminent transfer of the responsibility of liquor licensing from Magistrates Courts to local authorities, the role of the Licensing Committee and the way it conducts its business will likely be

reviewed.

- 3.4 Council established two Sub-Committees in 2003/04 with specific responsibilities relating to public entertainment licensing and human resources matters. It is proposed to reconstitute these bodies. The Licensing Committee (as the 'parent' Committee), at its first meeting in the Civic Year, will be invited to reconstitute these bodies.
- 3.5 In relation to Joint Committees, it is proposed that the Highways Partnership Panel should be retained throughout the next civic year in accordance with the latest Highways Partnership Agreement. The recently constituted joint Primary Care Trust (PCT) Scrutiny Committees will also be retained. It is intended that the rules of proportionally should continue not to apply to the joint PCT Scrutiny Committees.
- 3.6 Council, in November 2001, established a joint Member/employee panel, known as the Local Joint Panel to discuss, essentially, staffing issues and to report thereon to the Executive. It is proposed to retain this body throughout the next Civic Year.
- 3.7 A schedule detailing the proposed allocation of seats on Sub-Committees, should they be established during the year, is appended to this report (Appendix 'A' (Page 69.11)).

4.0 Political Groups

- 4.1 Where Members of the Council are divided into political groups, the provisions of the Local Government and Housing Act 1989 place a duty on the Council to review the allocation between those groups of seats on its Scrutiny Committees, Regulatory Committees and Joint Committee according to certain principles. The aim is to ensure that the political composition of the Committees etc reflects the composition of the Council. The rules of the proportionality do not apply to the Executive.
- 4.2 There are two duly constituted political groups within East Hertfordshire District Council. In addition, account must be taken of those Members, if any, who are not Members of political groups on the Council. Those Members are entitled to a proportion of seats in relation to their relative percentage size. It is for Council to appoint such Members to the seats allocated. Details of political group etc sizes are listed below:

Cons: 41 (82%)

Lib Dem: 5 (10%)

Councillors Atkins, Barnes, Sapsford and Warren are independent Members (2% each)

- 4.3 The recommendation at the head of this report identifies the need to allocate seats on the Council's Scrutiny and Regulatory Committees and its Joint Committees to political groups and non-aligned Members as required by legislation.
- 4.4 The Council is obliged to allocate seats to be occupied by its Members to the political groups into which it is divided. Political groups then nominate the Members of the Council whom they wish to see occupy those seats allocated to them. The nominees may not be a member of the political group which nominates them.
- 4.5 Council must appoint the nominees of the political groups to the seats allocated.
- 4.6 There is no provision within the Council's constitution for substitutes with the exception of the Local Joint Panel and Human Resources Sub-Committee.
- 4.7 Members of the Executive may not be appointed to serve on Scrutiny Committees. Executive Members may, however, if the Council so wishes, be appointed to the Regulatory Committees, the Local Joint Panel, Standards Committee and Highways Joint Panel (but not the joint PCT Scrutiny Committees).
- 4.8 The Executive has the power to constitute Executive Committees or Panels. Such panels may only comprise Members of the Executive. In the civic year 2003/04, the Executive established the Local Plan Executive Panel comprising two Executive Members. Additionally, representatives of other political groups were invited to attend to participate in the deliberations of this Panel.

5.0 Membership

5.1 Council is invited to note that Sub-Committees may comprise any Member of the Council (save for the exclusion referred to above concerning the Executive Members and Scrutiny Committees and if they were to be established Sub-Committees of Scrutiny Committees).

6.0 Standards Committee

- 6.1 The Council has established a Standards Committee consisting of one District Council Member from each political group of five Members or more, one Parish Council member, one Town Council member and two independent members.
- 6.2 At the Annual Council meeting in May 2002, the following two independent Members were appointed for a four year term following a selection and interview process:

Mr A Walker Mr J Morphew

6.3 The appointment of the Town and Parish Council representatives on the Standards Committee last year followed an invitation to all such authorities within the district to nominate candidates.

7.0 Community Voice

- 7.1 In October 2003, the Council established five Community Voices to provide local residents an opportunity to comment upon issues concerning their community. These were based around the five main towns in the District: Bishop's Stortford, Buntingford, Hertford, Sawbridgeworth and Ware. Council also agreed that rural communities' engagement needs should be dealt with via the convening of the Rural Parish Conference twice a year.
- 7.2 Council agreed that Community Voice should operate for a 12 month period with a review towards the end of that period. Community Voice meetings began in November/December 2003, therefore the review is scheduled to take place towards the end of 2004. It is proposed that the five existing Community Voice bodies are retained with the following Chairmen:

Bishop's Stortford : A L Burlton
Buntingford : S A Bull

Hertford : J D Thornton
Sawbridgeworth : D Richards
Ware : J J Taylor

8.0 The Executive/Leader of the Council/Constitution

8.1 At its Annual Meeting each year the Council is required to approve its constitution (with or without amendment). It is proposed that, at this

- annual Council meeting, the constitution be amended to reflect the issues detailed in this report.
- 8.2 Under the Council's constitution, it is for the Council to appoint the Leader of the Council (and also the Deputy Leader). At its annual meeting in 2003, Councillors M G Carver and H G S Banks were appointed as Leader and Deputy Leader. Effectively, these appointments are for the "life" of this Council (ie until next constituency election). The constitution sets out the circumstances when these posts will become vacant.
- 8.3 In terms of the appointment of Members to the Executive, the constitution provides that this is the responsibility of the Leader of the Council once appointed. However, Council determines the number of Councillors to be appointed upon the recommendations of the Leader. The Leader will report orally on his recommendations at the meeting.
- 9.0 Appointment of Chairmen
- 9.1 It is the practice of this Authority, to appoint Chairmen of Scrutiny Committees etc at the Annual Council Meeting.
- 9.2 The Council, the recommendation at the head of this report details proposed Chairmen of Committees etc for the ensuing civic year.
- 10.0 Calendar of Meetings
- 10.1 Council approved its calendar of meetings for 2004/05 at its meeting held on 25 February 2004. Under the Constitution, Council is required to confirm its programme of meetings for 2004/05 as follows:-

11.0 Outside Bodies

- 11.1 The Council appoints a significant number of people as its representatives on outside bodies. The appointment of such representatives is delegated to the Assistant Director (Law and Control), in consultation with the Leader of the Council.
- 11.2 The Head of Democratic Services and Leader are currently reviewing the Council's appointments for the ensuing civic year.
- 11.3 The Assistant Director, acting under delegated authority, will make appointments to outside bodies for 2004/05 in the near future.
- 12.0 Legal Implications
- 12.1 The proposals set out in this report accord with the statutory provisions for reviewing the Council's decision-making structure.

16.0 Recommendations

- 16.1 At the head of this report are several recommendations which seek to bring into effect for the 2004/05 civic year a division of the Council's duties and responsibilities in accordance with the Authority's existing constitution but subject to a number of amendments.
- 16.2 In advance of this meeting, the Head of Democratic Services has liaised with political group leaders in an order to obtain their nomination to their group seats on various bodies, where relevant. Details of these nominations will be circulated to all Members. Council is invited to note that one of the recommendations before them will enable these nominations to be appointed to the seats

allocated to groups.

16.3 The Council is invited to adopt the recommendations at the head of this report.
