663 REGIONAL SPATIAL STRATEGY SCRUTINY PANEL MINUTES

- 664 CONSULTATION ON THE REVISED REGIONAL HOUSING STRATEGY FOR THE EAST OF ENGLAND 2005 2010 AND HOUSING INVESTMENT IN THE EAST OF ENGLAND 2006 2008

A report was submitted by the Executive Member for Community on the Council's response to the Revised Housing Strategy for the East of England and Housing Investment in the region.

The strategy had been produced by a Regional Housing Board which had consulted with stakeholders, the Regional Housing Forum and the Regional Sustainable Community Panel. The region was divided into sub-regions of which East Herts was part of the London commuter belt sub-region.

A consultation document had also been published to develop the methodology for the allocation of resources at

a regional level. The documents highlighted the need for more affordable homes, improvement and maintenance of the condition of the existing stock, efficiency and effectiveness in commissioning housing, improving the quality of design, increasing choice for the customers and ensuring sustainability.

On the issue of sustainability, Members noted that the documents were closely aligned to the East of England Plan, which included greater housing growth than East Herts Council consider sustainable. Their comments would be relayed to the East Herts Housing Group and the Executive. They considered the response suggested by Officers and made a number of comments and amendments to it.

In addition, they noted references in the documents to changes to the planning system to ensure more affordable housing for keyworkers and young families in rural areas; powers to preserve the green belt; the need to provide infrastructure and jobs before housing and modern methods of construction. They discussed the possibility of a visit to a good example of a high-density site. The needs of travellers and the elderly were also considered.

Members were informed that Councillor R L Parker, the Executive Member for Community preferred option 1 of stage 2 because the Council no longer owned any housing stock. However, the Committee agreed to differ from this after discussions, because it felt more opportunities for funding were left open by option 2.

RESOLVED - that the East Herts Housing Group and the Executive be informed of the Policy Development Scrutiny Committee's comments, as now detailed, on the Revised Regional Strategy 2005 – 2010 and Housing Investment in the East of England 2006-08 for the submission to the Regional Housing Group.

Revised Regional Strategy

- it broadly welcomes the aspirations of the new Sustainable Communities: Homes for All proposals, subject to the Council's formal response to the East of England Plan, but reserves the right to consider more fully and submit a separate response on specific proposals contained in that publication;
- it welcomes the aspirations to achieve 40% affordable housing where housing stress warrants higher provision (para 7.1.1.7);
- it supports the greater integration of housing and planning policy, as reflected in the Council's own structure that brings housing and planning together within the Policy and Performance Division (7.1.1.15);
- it requests that the regional board considers a higher percentage of investment for local housing need and homelessness at the expense of the percentage given to growth – but otherwise supports the weighting given to themes in paragraph 7.1.1.20;
- it welcomes the statement made in paragraph 8.4.1.1 that endorses the importance of local strategies linked in to local community strategies and local strategic partnerships;
- it endorses the vision presented at 12.1.1.2 'to ensure everyone can live in a decent home at a price they can afford in locations that are sustainable';
- it reserves comment on the reference at 12.2.1.3 to the challenge of providing 478,000 new homes required by the draft East of England Plan for the Council's formal response to that plan;

Housing Investment in the East Of England

- it welcomes the increase in indicative allocation from £330m in 2004/06 to £445m in 2006/08;
- it broadly supports the methodology and the threestage approach to regional allocations, and in particular supports the development of a supply chain management approach;
- in relation to the invitation to submit views on specific issues (as set out from page 6 to 11 of the report before the Committee), the following views be expressed:
- a 5% portion of the Single Regional Housing Pot (SRHP) should be allocated to special issues and projects should be – regeneration and excellence and innovation in design quality and sustainability;
- (page 7) the Committee believes allocation should be made on the basis of need and the evidence of deliverability as identified through the supply chain management process irrespective of debt status;
- despite the views of the Executive Member for Community, within stage two, option 2 is preferred over option one as it would seem to allow a greater flexibility in tackling a range of needs and delivery options (page 8);
- (page 8) the Committee supports funds being made available to local authorities for purposes other than the decent homes target, e.g. initiatives designed to enable better access to and use of the private sector, prevention of homelessness, use of empty homes;
- whether or not the new funding arrangements can or should start in 2006/07 is to some extent a matter of capacity of the regional housing board. The new

arrangements should start in 2006 if possible;

- (page11) the three main indicators should be need, deliverability and value for money; and
- it suggests the regional housing board would be best placed to make strategic judgemental allocation decisions, so long as it developed sufficient capacity to respond positively to local needs and opportunities.

665 FORWARD PLAN FOR POLICY DEVELOPMENT SCRUTINY COMMITTEE

The Committee Chairman submitted a Forward Plan for the work of the Committee. He explained that the next meeting needed to be re-arranged as it was too close to the election.

The Committee supported the proposed Forward Plan and change of date.
