375 <u>LICENSING SUB-COMMITTEE</u>

Members expressed concern that more support was needed at Licensing Sub-Committee meetings from the Police. Officers explained there had been some changes to Police staff in Bishop's Stortford and suggested the Members of the Licensing Committee could be invited to the Night Time Economy Group to discuss this with the Police.

376 LICENSING ACT 2003, GAMBLING, SEX SHOP AND TAXI LICENSING : UPDATE

The Director of Neighbourhood Services submitted a report providing statistical information on the various licences issued by the Council under the Licensing Act 2003, Gambling, Sex Shop and Taxi Licensing.

Members raised concerns over taxi drivers parking on the pedestrianised area of Bircherley Green. A few examples had been considered by the Licensing Sub-Committee. The Licensing Enforcement Manager commented that the Committee's decision to issue warning letters had been very successful in deterring taxi drivers from parking in the area. The Chairman added that further legal advice would be sought on further action the Licensing Sub-Committee should take in these circumstances.

377 PUBWATCH SCHEMES IN EAST HERTS

The Director of Neighbourhood Services submitted a report on the Pubwatch Schemes in Hertford, Ware and Bishop's Stortford.

It was reported that Pubwatch was a forum for licensed premises owners, designated supervisors and managers to meet and discuss with the Police and other agencies issues such as Crime and Disorder, Banning Orders, Town Radio Links and other issues. The Neighbourhood Watch Co-ordinator and Town Watch Co-ordinators (Police appointments) and Licensing Enforcement Officer attended regularly.

The Licensing Enforcement Manager reported that Banning Orders were working well in Hertford and Ware but most of the orders in Bishop's Stortford had expired. He said that including attendance at the Pubwatch meetings as a condition on licensed premises had been successful.

The Committee agreed to note the report.

378 LICENSING ENFORCEMENT - 1 JANUARY 2008 TO 30 JUNE 2008

The Director of Neighbourhood Services submitted a report on compliance and enforcement activities in respect of premises licensed for the sale of alcohol, regulated entertainment and late night refreshments, licences for hackney carriage and private hire drivers, vehicles and operators and smoking and gambling legislation.
