7. ENVIRONMENT SCRUTINY HEALTH CHECK – AUGUST TO SEPTEMBER 2009

Purpose/Summary of Report:

• To set out an exception report on the performance of the key indicators that relate to Environment Scrutiny for the period August to September 2009.

(A) Performance be scrutinised and the Executive be informed of any recommendations.

1.0 <u>Background</u>

- 1.1 This is a performance report relevant to Environment Scrutiny Committee terms of reference covering the period from August to September 2009.
- 1.2 While Members will have already seen some of this information, this is the first opportunity for it to be presented in this format to Environment Scrutiny Committee.
- 1.3 The report contains a breakdown of the following information by each Corporate Priority:
 - An overview of performance, in particular where there have been issues and remedial actions taken during the period.
 - The indicators where data is collected monthly, with performance for September 2009 presented in detail (the most up to date available) with previous months summarised in a

- trend chart.
- The indicators where data is collected quarterly, with performance for Quarter 2 presented in detail (the most up to date available) with previous months summarised in a trend chart.
- 1.4 All Councillors have access to Covalent (the Council's performance management system), should they wish to interrogate the full range of performance indicators. The Performance Team is able to provide support and training on using the Covalent system if required.
- 1.5 <u>Essential Reference Paper 'B'</u> on pages 7.8 7.22 shows the full set of performance indicators that are reported on a monthly and quarterly basis to this committee. Essential Reference paper B has been sorted by status, e.g. all performance in 'red' have been listed first etc.

2.0 Report – Indicators grouped by Corporate Priority

Caring about what's built and where

Performance analysis

2.1 **EHPI 204 – Planning appeals allowed.** Performance is currently in 'Red' for September 2009. 8 out of a total 15 appeals were allowed in September 2009. The allowed appeals related to new residential schemes at Bonks Hill House, Sawbridgeworth, Upper Green Road, Tewin, The Castle PH, Bishop's Stortford, a gypsy/traveller proposal at The Stables and Bayford. Other allowed appeals were for householder schemes.

- 2.2 EHPI 2.10(3) Percentage of building sites re-inspected in less than 3 months. Performance is currently in 'Red' for September 2009. Within the resources available, priority is being given to statutory inspection and plan checking work that are important elements for assessment. It is considered that this is the most suitable priority and therefore the best use of resources for the foreseeable future. Performance was slightly below target for August 2009 having achieved 68%, this was due to staff taking annual leave and loss of an agency surveyor.
- 2.3 Officers recommended that no action be taken in relation to 'EHPI 2.10(3) percentage of building sites re-inspected in less than 3 months' pending assessment of the service through the C3W process.
- 2.4 EHPI 2.2(45) Waste: missed collections per 100,000 collections of household waste. Performance is currently in 'Red' for September 2009. Performance is stable compared to August 2009. Changes to round structures in preparation for ARC have adversely affected garden waste collection performance, but year to date performance remains better than target.
- 2.5 Performance in August 2009 was below the target having achieved 57.28; this was due to problem with a rural crew not completing their work. Contract management penalties have been applied and contractor has taken remedial action.
- 2.6 NI 157b Processing of planning applications: 'Minor' applications. Performance is currently in 'Amber' for September 2009. Decisions were made on 7 applications outside of the target period. Six of these were delayed as a result of reporting to the Development Control Committee. These matters were reported to the committee either because they related to sites on which the committee had taken decisions previously, or the advice given was that a decision other than in accordance with the Councils planning policies was appropriate which therefore requires the matter to be reported to the committee.
- 2.7 NI 157c Processing of planning applications: Other applications. Performance is currently in 'Amber' for September 2009. The delay in a number of the 'other' application decisions was a result of decision making by the committee. Items were reported to the committee due to referral or as the proposals were supported, but contrary to planning policy.

- 2.8 There were no applications made in the June 2009 period so no performance data has been recorded.
- 2.9 EHPI 2.23(188) Planning decisions delegated to officers.

 Performance is currently in 'Amber' for September 2009. The target was not met because 20 out of a total 177 decisions required a committee decision. The constitution requires that certain types of application must be determined by the committee rather than an officer. This performance indicator is adversely affected when planning applications of certain types increase and/or referrals are requested. Officers, in consultation with the committee chairman, try to keep referrals to a minimum.
- 2.10 Performance in the following indicators were 'Green', which means that targets are either being met or exceeded between August 2009 to September 2009. They are:
 - NI 157a Processing of planning applications: Major applications.

Performance analysis

- 2.11 Performance in the following indicators were 'Green', which means that targets are either being met or exceeded between August 2009 to September 2009. They are:
 - EHPI 218a Abandoned Vehicles % investigated within 24 hours
 - EHPI 218b Abandoned Vehicles % removed within 24 hours of required time.
- 2.12 The following National Indicators were introduced for the first time in 2008/09. There is no historic data available so no targets could be set for 2009/10. The service will explore setting new targets after a complete years of data in 2009/10 has been collected for benchmarking:
 - NI 191 Residual household waste per household.
 - NI 192 Percentage of household waste sent for reuse.

Fit for purpose

- 2.13 **EHPI 6.8 Turnaround of pre NTO PCN challenges.** Performance is currently in 'Red' for September 2009. Performance has improved from last month having achieved 22 days in August 2009 and 17 days in September 2009. However 2 working days were lost due to a power cut and internet line failure.
- 2.14 EHPI 7.0 % pre NTO PCN challenges responded to within 10 days. Performance is currently in 'Red' for September 2009. Performance has improved since last month having achieved 12% in August 2009 and 32% in September 2009. However two days were lost due to a power failure and loss of internet connection.
- 2.15 Performance in the following indicators were 'Green', which means that targets are either being met or exceeded between August to September 2009. They are:
 - EHPI 6.9 Turnaround of PCN Representations.
 - EHPI 7.1 % PCN Representations responded to within 28 days.
