639 A REVISED MODEL CODE OF CONDUCT FOR LOCAL AUTHORITY MEMBERS

The Head of Democratic Services submitted a report inviting it to consider the Government's consultation paper on a draft of a proposed new Model Code of Conduct for Local Authority Members.

The Committee noted the draft revised code was the Government's response to the recommendations of the Standards Board for England who conducted a review of the present code in 2005. The deadline for submission of comments was 9 March 2007.

The Monitoring Officer drew the Committee's attention to an appendix to the report that contained commentary on the detailed amendments proposed.

ACTION

The Committee noted the proposed amendments to the model code relating to:

- unlawful discrimination;
- bullying;
- disclosure of confidential information in response to the specific question on this proposal, the Committee agreed that the proposed text on the disclosure of confidential information did strike an appropriate balance in the circumstances detailed;
- behaviour outside official duties in response to the specific question on this proposal, the Committee accepted the proposed text which limited the proscription of activities in members' private capacity to those activities which had already been found to be unlawful by the courts;
- the commission of a criminal offence before taking office;
- using or seeking to use improper influence
- publicity code in response to the specific questions on this proposal, the Committee felt that the Code did serve a useful purpose and that all authorities should be required to follow its provisions;
- reporting breaches of the code and proscribing intimidation;
- gifts and hospitality in response to the specific question on this proposal, the Committee felt that current arrangements were appropriate;
- body influencing public opinion or policy;
- interests of family, friends and those with a close

personal association - in response to the specific question on this proposal, the Committee felt that the proposed text represented an improvement compared to the provisions within the current code;

- definition of personal interests;
- disclosure of personal interests;
- public service interests;
- prejudicial interests list of exemptions in response to the specific question on this proposal, the Committee agreed that it would be appropriate for new exceptions to be included as additions to the list of items which were not to be regarded as prejudicial;
- overview and scrutiny committees;
- participation in relation to prejudicial interests in response to the specific question on this proposal, the Committee welcomed the revision detailed;
- sensitive information;
- national park and board authorities prejudicial interest:
- register of members' interests, and
- gender neutrality of language in response to the specific question on this proposal, the Committee supported the use of the word "you".

The Committee agreed to request the Monitoring Officer to respond to the specific questions listed within the consultation paper on the basis now detailed.

RESOLVED - that the Monitoring Officer be requested to respond to the specific questions listed within the Government's consultation paper on a
