MEMBERS' QUESTIONS

Question 1

Councillor Ben Crystall to ask Councillor Graham McAndrew, Executive Member for Environmental Sustainability:

According to the final report from the Climate Change Task and Finish Group, received by Council on 5th March 2019, it was recommended that existing capital grants for loft and cavity wall insulation are extended to provide greater assistance grants to cover solid wall insulation and secondary glazing in energy efficiency priority areas of the District. It was also suggested that this could be achieved from within the existing capital budget, as current loft and cavity wall grants are under-utilised by residents. Has this extension to the grant offer been provided, and if so, can he provide specific figures for the total amount allocated to solid wall insulation and to secondary glazing, and how much of this allocation has been actively granted to residents for this purpose?

Question 2

Councillor Ben Crystall to ask Councillor Graham McAndrew, Executive Member for Environmental Sustainability:

The Council, as a trusted local information source, should continue to promote information on energy reduction to local residents. The Grantham Institute at Imperial College recently published a list of 10 straightforward actions that individuals can take to reduce their own carbon emissions; will EHDC commit to placing this list in a prominent place on its website and publishing it in the Council's publications such as Link and Network?

Question 3

Councillor Rosemary Bolton to ask Councillor Peter Boylan, Executive Member for Neighbourhoods:

What steps is the Council taking to tackle anti-social behaviour within our District?

Question 4

Councillor Jeff Jones to ask Councillor Graham McAndrew, Executive Member for Environmental Sustainability:

Could the Executive Member assure me that this council is committed to supporting Community Transport projects in our district? These services rely heavily on the financial support given by East Herts Council, until they become self-sustaining. Can the Executive member assure me that there are no plans to reduce this financial commitment?

Question 5

Councillor Devonshire to ask the Councillor Jan Goodeve, Executive Member for Planning and Growth:

How is this council seeking to protect employment land within our District?

Question 6

Councillor Chris Wilson to ask Councillor Graham McAndrew, Executive Member for Environmental Sustainability:

During the full Council meeting on 23rd October, this Council unanimously agreed to a motion proposing that the Environmental and Climate Change Forum would investigate the possibility of working with Hertfordshire County Council to research the possibility of setting up an "On-Demand" Transport service in East Herts. As planned developments are continuing to progress within the District, it is vital that we set up more viable alternatives to private car use as soon as possible. Therefore, I would ask Councillor G McAndrew to update the Council on any progress that might have been made with such an investigation, and if no progress has been made, please inform us when we are likely to hear any updates about the possibility of putting an On Demand Transport system in place?

Question 7

Councillor Mione Goldspink to ask Councillor Peter Boylan, Executive Member for Neighbourhoods:

Several years ago this Council made a commitment to help with the Government's programme for resettling vulnerable Syrian refugees. These were vulnerable people from the Refugee Camps who, had been assessed by the UNHCR (United Nations High Commission for Refugees) as being in genuine need. Could the Leader please give an update on this Council's activity with this programme, and tell us how many Syrian refugees have been settled in East Herts?

Report title: Council Tax – Formal Resolution

Summary

This report sets proposals to set the Council Tax for 2020/21

RECOMMENDATIONS FOR COUNCIL:

- (a) that the Council Tax resolution, as now submitted, be approved;
- (b) that the local precepts as set out at Appendix 'A' be noted; and
- (c) that the Hertfordshire County Council and Hertfordshire Police Authority precepts be noted.
- 1.0 Proposal(s)
- 1.1 The council tax resolution is set out at Appendix A.
- 1.2 The calculations set out in the resolution are prescribed in the Local Government Finance Act 1992 as amended. The Localism Act 2011 made minor amendments to the required calculation. The Council has no discretion in undertaking these calculations beyond determining any special expenses within

the Council's own budget applicable to part of its area. The Council has not determined any special expenses.

1.3 <u>The Required Calculations</u>

- 1.4 Section 1: this confirms that this Council's previously agreed Tax base is used in the calculation.
- 1.5 Section 2: this sets out the Council's council tax requirement for its own purposes (excluding parish precepts) for 2020/21.

1.6 Section 3:

- (a) The Council's gross expenditure + transfers to reserves + the total of parish precepts.
- (b) The Council's gross income including grants + transfers from reserves.
- (c) ls(a) (b)
- (d) Is (c) divided by the tax base. This is this Council's band D council tax rate + the average rate for all parishes.
- (e) Is the total of parish precepts.
- (f) Is this Council's band D council tax rate.
- (g) Is a table of Band D Council plus Parish rate.
- (h) This is the same as (g) but showing the council tax by each valuation band.
- 1.7 Section 4: this is the equivalent amounts to those at 3(h) for the County and Police Authority precepts
- 1.8 Section 5: this is the total council tax for each valuation band for each parish

2.0 Background

2.1 This Council is the council tax billing and collection authority within its area.

- 2.2 The council tax calculation sets the tax in respect of this council and the aggregate council tax inclusive of the County Council and Police Authority precepts and of each town and parish's precept.
- 2.3 The County Council's Finance Director and Chief Finance Officer for the Police and Crime Commissioner have advised that the County Council and Police Authority precepts for 2020/21 as they affect East Hertfordshire District Council taxpayers will total £98,782,718.40. This is made up of £86,650,862.40 for the County Council and £12,131,856.00 for the Police Authority. This gives Band D equivalents of £1,414.20 and £198.00 respectively.
- 2.4 The total parish precept is £4,781,811.81.
- 2.5 The County Council, Police Authority and Parish precepts contribute to the setting of the Council Tax

3.0 Reason(s)

3.1 The Council has a statutory responsibility to set the council tax for each part of its area no later than 11 March prior to the start of the year in respect of which the tax is set.

- 3 That the following amounts be now calculated by the Council for the year 2020/21 in accordance with Sections 31 to 36 of the Local Government Finance Act 1992:
 - a) £ 94,089,165.81 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (2) of the Act taking into account all the precepts issued to it by Parish Councils
 - b) £ 78,640,511.52 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (3) of the Act
 - c) £ 15,448,654.29 being the amount by which the aggregate at 3 (a) above exceeds the aggregate at 3(b) above, calculated by the Council, in accordance with Section 31 A(4) of the Act, as its Council Tax requirement for the year. (Item R in the formula in Section 31B of the Act)
 - d) £ 252.13 being the amount at 3(c) above (Item R), all divided by item T (1(a) above), calculated by the Council, in accordance with Section 31 B of the Act, as the basic amount of its Council Tax for the year. (including Parish Precepts)
 - e) £ 4,781,811.81 being the aggregate amount of all special items (Parish precepts) referred to in Section 34(1) of the Act, as detailed above.
 - f) £ 174.09 being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by item T (1(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council tax for the year for dwellings in those parts of its area to which no Parish precept relates

The Council is also required to determine that the Council's basic amount of Council Tax for 2020/2021 is not excessive in accordance with principles approved under Section 52ZB and 52ZY Local Government Finance Act 1992 and Section 4ZA Local Government Finance Act 1992: Referendums relating to Council Tax Increases.

For 2020/2021 the level deemed to be excessive, as determined by the Government in its Referendums Relating to Council Tax Increases (Principles) Report (England) 2019/2020, is an increase of 1.99% or more, or £5 per dwelling whichever is the greater. As such, the Council can determine, for its portion of the Council Tax that the level of Council Tax increase for 2020/2021 is not excessive or requiring a local referendum.

<u>EU SETTLED STATUS FOR EU CITIZENS LIVING IN THE EAST HERTS</u> <u>DISTRICT FOLLOWING BREXIT</u>

Background

Part 3 of the Withdrawal Agreement Bill (WAB) gives powers in UK law to implement provisions for protecting citizens' rights in the Withdrawal Agreement (WA), and the similar separation agreements with Switzerland and with the EEA EFTA states – Iceland, Liechtenstein and Norway. The citizens' rights provisions in the WA set out a framework for the continued legal residence (and associated rights, including social security and healthcare rights) of EU citizens living in the UK, and UK nationals living in the EU, at the end of the transition or implementation period (31 December 2020). EU citizens may apply for EU Settled Status, with the deadline being no sooner than six months after the end of the transition period. Currently this is 30 June 2021.

The House of Commons issued as briefing paper, '8772 Citizens' rights provisions in the European Union (Withdrawal Agreement) Bill 2019-20' on 3 January 2020. This highlighted that some EU citizens may be unware of the need to apply for settled status or have difficulty in doing so.

2.2 'it has been estimated that about 30% of EU citizens may struggle with the EUSS application process, whether due to a lack of awareness of the scheme or difficulties making an application or proving their eligibility. They are therefore particularly vulnerable to losing their status and entitlements in the UK. Groups identified include the elderly, people with limited English, children and young people in the care system, homeless people, people who arrive soon before the deadline and people in casual employment.'

Officers at East Herts District Council have undertaken commendable work to ensure the EU citizens are aware of the requirement to apply for settled status. An update on progress was last issued in August 2019. The Council has some information for EU citizens on its website;

As the deadline approaches there is an opportunity for the Council to ensure that EU citizens know they remain welcome in the District and to improve information for residents.

MOTION

In relation to 'Part 3 of the Withdrawal Agreement Bill' and the requirement for EU citizens to apply for EU Settled Status this Council:

- 1. declares that EU citizens are welcome in the District of East Herts.
- 2. will undertake an urgent review of the information it provides on its website and elsewhere to ensure that all EU citizens, including vulnerable groups and those with impairments have easy access to information regarding how to apply for EU Settled Status.
