<p>Question 1</p>	<p>Cllr Joseph Dumont to ask Cllr Graham McAndrew, Executive Member for Environmental Sustainability:</p>
<p>At Council in July of last year, I brought to the attention of the Executive Member for Environmental Sustainability the issue of litter in our District. I asked what was being done to hold the Contractor to account. The Executive Member assured me that he was meeting regularly with Officers and that this Council had powers to act if need be. He told me;</p> <p><i>'contracts have performance management regimes in place which bear financial deductions should cleansing not be achieved at the standard we expect'</i></p> <p>Since I asked this question, last year I'm sorry to say the situation has gone from bad to worse. The very stretch of verge, the A414 slip road into Stanstead Abbots, which was the section first brought to my attention as being a significant location for litter and fly tipping has still not been picked. This is despite the situation being raised many months ago. There have been phone calls, site inspections and emails about this one short stretch of verge, yet it remains an awful mess.</p> <p>Across our Distirct, the community has taken matters into its own hands, notably the Wombles of WareAbouts and also TUBS in Bishop Stortford. These are members of the public out and about picking litter because they want to live in a clean and tidy environment. Surely in East Herts not having rubbish all over the place is not too much to ask.</p> <p>Will the Executive Member please join me in thanking the Wombles and members of TUBS for their good work, update me on his</p>	

progress, specifically if the powers of 'contract management' have been applied and tell me when he expects the verge off the A414 into Stanstead Abbots to actually be cleaned?

Co-operation for Sustainable Development Board

Purpose:

Herts Infrastructure and Planning Partnership

Purpose:

The Hertfordshire Infrastructure and Planning Partnership (HIPP) provides a forum to discuss and, where appropriate, develop a shared view and agree joint work programmes on infrastructure and planning issues of common concern. A key objective is to work co-operatively within Hertfordshire and across the county borders according to the principles of localism and the duty to co-operate.

The partnership has developed new terms of reference following the creation of the Herts Growth Board. The HIPP will work closely with the HGB to ensure that the board is kept fully aware of planning and infrastructure needs. In 2018 HIPP commissioned the Infrastructure and Funding prospectus which details the funding requirements for each of the districts and boroughs.

The Chairman, or his or her deputy, represents the Partnership as appropriate on external bodies, including the Board of the Local Transport Body for Hertfordshire.

The Partnership is not a formal decision making-body and does not fetter the decision making processes of individual authorities. If individual authorities come to a different view from any collective Hertfordshire position they will ensure that all the other authorities are duly notified.

The Innovation Corridor

Purpose:

The London Stansted Cambridge Corridor Consortium is a partnership of public and private organisations covering the area north of Tech City, the City Fringe, Kings Cross, and the Olympic Park, up through the Lee Valley and M11/A10, and West Anglia Rail corridors to Harlow and Stansted, and through to Cambridge. The partnership was formed to organise and promote a clear economic area, with strong inter-connections; commuting to work and learn patterns, clusters of industries and supply chains.

Update:

The Innovation Corridor (previously called the LSCC) continues to make good progress in developing a coherent message for promoting growth along the corridor. A policy/briefing document has been produced outlining the benefits of investing in the Innovation Core which is the section not including London and Cambridge.

The LSCC board meets at least 4 times a year. There are also training sessions and ad hoc presentations and conferences

The districts and boroughs which make up the centre of the corridor – Broxbourne, East Herts, Harlow, Epping Forest and Uttlesford work closely together to create an economic vision for this area.

Also, East Herts, both at a political and senior Officer level, is an active Member of those authorities in the middle of the corridor.

Its approach is to be community focused and commercially driven, to work with partners to produce a unique combination of activities, sights and experiences.

The Authority took back the 14 sport and leisure venues and their associated staff from the Trust and have been running the venues when they have been allowed to open.

Covid meant most venues were closed throughout the year, which has had a major impact on the financial situation.

The Authority has raised the precept by 2% this year to help off set the financial impact of Covid and it is hoped that the centres will be fully up and running as soon as possible as the lockdown restrictions ease.

Network Homes – Hertford and Out of London Area Panel

Purpose:

To ensure local residents and elected members are able to influence the future quality of housing provision for residents in East Hertfordshire

Update:

This panel meets quarterly and is chaired and composed of a range of tenants from Network properties. Both East Herts panel members usually attend all of the meetings.

Over the course of the year Network Homes has consulted and informed on strategies to evoke positive interaction as well as dealing with complaints and requests. There have been discussions over rent arrears to the lockdown, parking problems, and systems of neighbourhood management. The Panel has also been consulted on their views about overcrowding, the need for more family homes and the strategies to persuade some residents to downsize. As with most organisations Network Homes wish upgrade their customer care department including to digitising their communications without compromising their service to more vulnerable residents.

They are trying to manage the Business Transformation plan sensitively and carefully using surveys of resident 'satisfaction' in an effort to do so. There is a very real fear and reluctance of many tenants to engage in this way but there are also plans to aid residents to access the necessary IT skills. Network homes are making strenuous efforts to follow up and solve maintenance issues. Although the organisation has no high-rise buildings in East Hertford there has been a good discussion on how the expense of dealing with ensuring safety in properties owned in Watford and London, could have an indirect impact on East Herts residents if the costs of

refurbishment cannot be met. Less revenue would mean a lower ability to build much needed homes. This is an ongoing problem that the organisation is trying to tackle through interest free loans to leaseholders in the affected buildings.

Hertfordshire Armed Forces Covenant Board

The Covenant Board met twice this year, via virtual meeting. The Board has representatives from all District and Borough Councils within Hertfordshire, members from the emergency services, reps from two military charities and other interested stakeholders.

The welfare of the Armed Forces, both serving personnel and veterans, remains high in the Government's priorities since Boris Johnson became PM. He has created the Office of Veteran Affairs and introduced the Veterans Bill. Within Hertfordshire, the Board seeks to promote the Armed Forces and ensure that Veterans have full access to public services and are celebrated for the work they do.

This year, Hertfordshire will celebrate the ten-year anniversary of the signing of the Hertfordshire Armed Forces Covenant. A number of events are going to be held, in-line with social-distancing rules.

Lastly, members should by now be aware of the veterans portal, which aims to signpost individuals to help and advice on all issues relating to the Armed Forces.

Stansted Airport Consultative Committee

Purpose:

Provides community consultation in regard to the workings of Stansted Airport. Its specific terms of reference are:

1. To consider, scrutinise and advise on matters primarily concerning the management and administration of the Airport.
2. To consider the impact of the Airport on the local community, the economy and the environment.
3. To consider matters affecting the experience of Airport users including passengers.
4. To consider the corporate affairs of the Airport.
5. To promote an informed understanding of airport operation and of their impact on communities of interest.
6. To consider matters specifically referred by interests represented on the Committee, by the management of the Airport or by the Government.
7. To share ideas and consider best practice from other airports and organisations.
8. To liaise with other Airport Consultative Committees on matters of common concern.
9. To make representations to the Government and other organisation as appropriate and
10. To take any action incidental to any of the above terms of reference, including co-options, the establishment of Working Groups and nominations to Outside Bodies.

Update:

This year, the number of meetings, have been reduced, owing to Covid19. Despite restrictions, I have attended several meetings, via virtual platforms, of the full committee (STACC) and the Future Airspace Consultation Steering Group. Owing to the pandemic Stansted airport has seen a huge reduction in passenger activity, but

freight cargo has been steady. The airport has also hosted a drive-in testing site.

There have been two important issues for members to be aware of. The first has been the planning hearing into Uttlesford DC decision to rescind the permission for Stansted's expansion to 43 million passengers per annum. Whilst we await the decision, there has been a dramatic local fallout and the Stop Stansted Expansion group have decided to rebrand.

The other important issue is that the Future Airspace Programme continues to move along on schedule. This is a national directive passed down from the Civil Aviation Authority and the DoT. The scheme is to consult and then design possible changes to arrivals and departures from the airport. (Luton are doing the same). The airport is leading on the consultation for flight paths below 7000ft and NATS will be conducting a similar review of airspace above that level. My role is to voice an opinion on the approach to consultation. I shall be working with officers to ensure that the consultation is communicated to our members and residents effectively.

Update:

The challenge

Working in a two-tier authority area involves recognising and respecting individual strategies and plans, whilst seeking to collaborate. A significant challenge is managing expectations, identifying relevant issues for all partners and matching that to resources available to deliver on plans.

The solution

The solution was to form a joint partnership with the county council, all 10 districts and boroughs and the Herts LEP. This proposal received unanimous support and agreement and resulted in the establishment of the HCCSP - with representation at leader or executive member level.

The partnership takes a collaborative approach to tackling wider issues outside of the direct control of individual authorities, to meet targets related to climate change including meaningful carbon reduction. Four initial priorities and joint Strategic Action Plans have been drafted to tackle specific countywide issues.

Water

A Strategic Water Action Plan has been prepared with engagement from water companies, the environment agency and lead local flood authority. The plan was approved by HCCSP in January, subject to consultation with strategic planning groups across the county.

Key features:

- optimise use of building regulations
- improve consultation and engagement with water companies and the environment agency on local plans

- improve consistency on planning policy
- behavioural change campaigns

Biodiversity

HCCSP agreed to a countywide biodiversity baseline to enable identification of opportunities for biodiversity improvement and to develop an evidence base for biodiversity net-gains. The draft Biodiversity Action Plan was presented to the partnership in March and received agreement in principle.

Key features:

- countywide approach to biodiversity net gain
- countywide map of opportunities
- influencing policy at local level
- education and awareness raising

Carbon Reduction

This plan is in the development stages and focusses on a consistent approach to monitoring and reporting carbon emissions, improved training for Local Authority staff, identifying opportunities to reduce local authority emissions, and to reduce emissions more broadly, e.g. working with businesses.

Transport

This plan is in the development stages and will align with the delivery of current policies and policy change options in areas including; electric vehicles, taxi licensing, and co-ordinated long-term behaviour change campaigns.

The impact (including cost savings/income generated if applicable):

The Partnership has made considerable impact in a short space of time; increasing the collaboration of partners and enabling a greater sharing of opportunities through joint work. Officers have established a network of peers, which has proved invaluable and the

workstreams have fostered stronger working relationships with colleagues in other service areas to work on realising the ambitions.

Virtual HCCSP meetings have enabled cost savings, increased participation and reduced carbon emissions.

How is the new approach being sustained?

The partnership was set up with agreed Terms of Reference and established a Hertfordshire Sustainability Officers group (HSOG) to support action planning and implementation of work plans. The key themes have specific tasks and officer subgroups, with a local authority officer as lead, responsible for setting up meetings and ensuring buy-in and ownership of the plans.

The HCCSP and its officer group (HSOG) meet every six weeks; both groups have good attendance from all partners and the subgroup leads also meet six-weekly. The partnership is jointly funded by all members and has employed a dedicated coordinator to facilitate its work.

Community engagement events are planned for this year, including a COP26 event in November. There is an ongoing focus on identifying funding opportunities and sharing best practice between partners

Hertfordshire Lifestyle Network

Purpose:

Originally set up to continue the legacy created from the Olympics in 2012

Update:

Formed after the 2012 Olympics this partnership has provided important links across County and District Councils, Herts Sports Partnership and other Community and Voluntary organisations. The 'Year Of' initiatives such as Year Of Physical Activity and Year of Culture were intended to create a legacy of community activity and involvement to bring strength to our society. The Year of Culture was unable to take place as originally envisaged owing to Covid but a great attempt was made to provide alternatives on line and promote them as much as possible.

Proposal for a cultural strategy for Hertfordshire

One of the initiatives reported on was a new Crowdfunding Platform Hertfordshire Community Foundation (HCF) presented a progress report on *Crowdfund Hertfordshire*, the crowdfunding platform for Hertfordshire. It was noted that the crowdfunding Hertfordshire platform has been able to grant funds to four initiatives, supporting local not-for-profit organisations to deliver services that will support vulnerable adults.

Crowdfunder has been seen as a fun way to fundraise amongst Hertfordshire's local communities. Additional funds are to be included as part of the Crowdfund Hertfordshire process. This includes the Hertsmere Borough Council's CIL Fund and the East Herts Community Fund.

HACO reported that It was expected that COVID-19 will have a significant impact on the Arts & Culture and Leisure industries across the nation as well as the county of Hertfordshire. It is estimated that there will be a £30.6 billion loss from visitors coming into the UK. The tourist industry is not expected to recover until 2023, 2024. As such HACO recommended that Hertfordshire public sector organisation invest in customer support, helping to reassure residents and local businesses during the recovery process.

From Voluntary and Community Sector we learned about the achievements and challenges faced by the VPA Cell during the COVID-19 pandemic in Hertfordshire. The multi-partnership delivery of Operation Sustain and Shield helped to support isolated and vulnerable individuals during the lockdown period. It was noted that Operation Sustain was responsible for coordinating in excess of over 10,000 volunteers in Hertfordshire. Support is now being provided to carers and frontline service workers, with support mechanisms in place to look after the physical and mental health of these individuals during the recovery process.

From the Herts Sports Partnership we discovered the important role sports club will play in tackling the expected mental health challenges that will arise as a result of the Covid-19 pandemic. To combat this, 250 coaches have been trained by Sports England to address mental health challenges, both in children and adult's sports teams.

Also highlighted was the key role Sports England will play in the delivery of mentor programmes, helping children adjust to the "new normal" as a result of the easing of lockdown restrictions. There will also be a review of Sports England's strategic priorities, evolving around what they stand for as an organisations and revolutionising how they will deliver their services.

In Terms of Art and Culture a case is being made for a County wide Cultural Strategy. Covid-19 pandemic is having a negative impact on most sectors, and there is growing evidence that shows that the impact on the leisure, creative and cultural sectors may be particularly devastating. There is a case to identify Covid-19 impact and work on finding solutions and funding to help the sectors. Developing a Cultural Strategy for Hertfordshire has the potential to help the county develop a clear vision and long term plans that would enable the creation of projects that benefit the sectors. The Arts Council England is supportive of the process and has indicated that an overarching strategy for Hertfordshire could have the potential to unlock funds to help develop businesses, structures and communities. It is envisaged that the overarching strategy will define themes of interest. Whilst it is hoped that this strategy may identify some areas in which HLN partners may wish to work together, it is envisaged the strategy will primarily be a tool for partners such as districts and boroughs to adapt to their own local plan of action.

Finally In 2020 it was decided to review and refresh the remit of HLLP. As part of this, the partnership was renamed the **Hertfordshire Lifestyle Network.**

The aim of the Hertfordshire Lifestyle Network:

- a) To act as a network of partner organisations within Hertfordshire to discuss issues of common interest in the areas of culture, sports, physical activity and lifestyle.
- b) To share best practice, identify and discuss areas of potential joint working.
- c) To explore the possibility of pursuing possible funding opportunities.
