Petition - Back off our bins!

We, the undersigned residents of Hertford & Stortford, call on the Green & Liberal Democrat leadership of East Herts District Council to rethink their disastrous new bin collection policy.

From August, they are cutting bin collections to once every 3 weeks, while forcing households to manage five different bins. This will take up extra space, and may leave rubbish piling up outside homes. If you miss a collection, you could be waiting six weeks for your next one!

In the Council's own consultation, 88% of respondents said the Council should continue to provide fortnightly waste collections. They didn't listen to residents before making this decision. It's time to make them listen now.

We demand that East Herts District Council puts common sense first, listens to local residents, and scraps this unworkable scheme.

For the period April to November last year East Herts had 483 recorded incidents of fly tipping.
