

Community Governance Review of Buntingford Town Council

ESSENTIAL REFERENCE PAPER C

HAVE YOUR SAY

East Hertfordshire District Council is carrying out a review of the area served by Buntingford Town Council including the town/parish boundary. All local residents and organisations are invited to give their views.

What is a Community Governance Review?

A Community Governance Review is a formal process which can result in changes to town/parish areas or electoral arrangements to represent local communities.

Parish and town councils are the most local tier of government in England. They can play an important role in empowering their communities, may comment on planning applications and manage or provide services at the local level.

Issues under consideration

The review is being undertaken following a request from Buntingford Town Council. The town council asked East Hertfordshire District Council to consider whether changes should be made to the town/parish boundary to include the following developments within the area of Buntingford Town Council:


- Parkside and new development north of the town boundary and currently in Cottered parish; and
- Buntingford Business Park, currently in Aspenden parish.


East Hertfordshire District Council needs to know the views of local residents and other interested parties in order to decide whether any changes should be made.

Please tell us what you think about the changes suggested by the town council or any other issues concerning parish or ward boundaries or electoral arrangements at the town/parish council level.

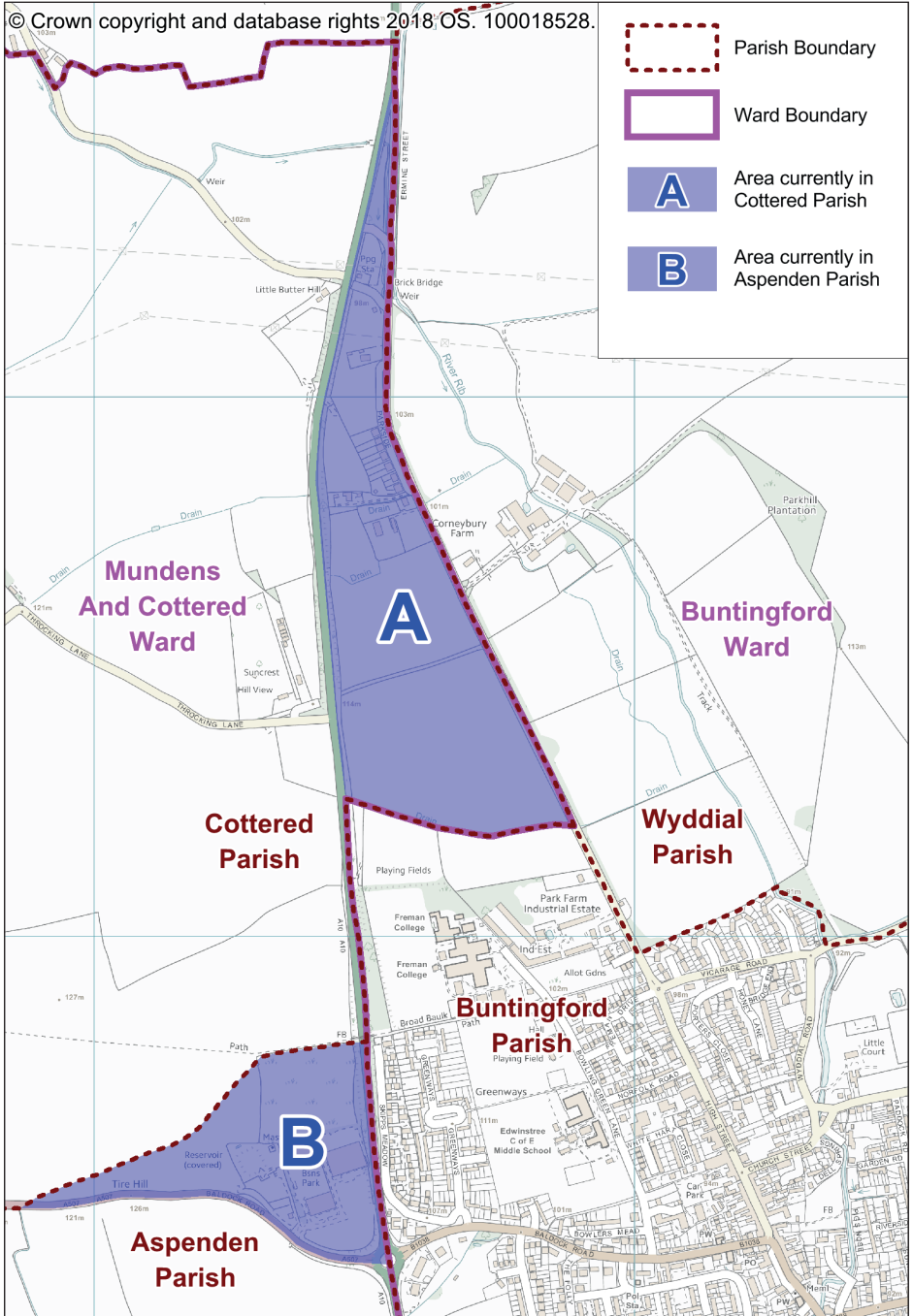

Map

The map below shows the current boundary of Buntingford Town Council with Cotteder Parish Council and Aspenden Parish Council. The areas identified by the town council for consideration in the review are shaded on the map.



How would residents be affected?

The review could result in changes to town/parish boundaries. For example an area that is currently within Cottered parish or Aspenden parish could instead become part of Buntingford parish. Starting with the town and parish council elections in May 2019 residents of that area would elect councillors to represent them on the town council.

The level of council tax paid by some residents could also vary due to differences in the 'precept' levied by each town or parish council. A precept is an amount charged by the town or parish council to provide additional local services. East Hertfordshire District Council collects this money as part of the council tax and passes it on to the town or parish council. The table below shows current information about Buntingford Town Council, Aspenden Parish Council and Cottered Parish Council. Information on any services delivered is available from the relevant town or parish council.

Why your views are important

In carrying out the review, the council must seek to ensure that any proposals:

- reflect the identity and interests of the community in the area;
- promote effective and convenient local government;
- take into account any other arrangements for community representation or engagement in the area; and
- promote community cohesion.

The council believes that parishes should reflect distinctive and recognisable communities of interest with their own sense of identity and that electors should be able to identify with the parish in which they live. The wishes of local inhabitants and any submissions providing evidence of community identity or local linkages are therefore important considerations in this review.

East Hertfordshire District Council will consider all submissions received during the review before reaching its final decisions.

The timetable for the review

Initial submissions should be sent to East Hertfordshire District Council by online form, email or in writing at the contact details below by **Friday April 6 2018**. East Hertfordshire District Council will consider those submissions before publishing its draft recommendations for further consultation from May to July 2018.

The review will conclude when the council publishes its final recommendations by October 2018.
