White Cottage stables inaccurate, The Cottage earlier garage building inaccurate.

There are no trees west of The Cottage on the triangle.

5.2 EEG is atypical - name another Hertfordshire hamlet without a metalled roadway crossing the green ?

It is even too small for a post box or gas supply!

Keepers Cottage - two storey plus attic. No attic casement to porch. Converted to single dwelling and extension added in

1970's

The Cottage - 'TeaS with Hovis', a popular venue for cyclists. ....been approveD....

(The caravan occupants added greatly to the colourful diversity of the EEG population, and are worth recording - see planning history )

White Cottage - The current stabling and matching double-pile rear extension are late 20<sup>th</sup> C additions.

5.12 Southern views towards the valley are already important glimpsed from the RUPP junction with FP 3A. Currently obscured by now obsolete gravelling 'amenity bunds' they are now under threat of fresh further large scale unapproved Green Belt land raising . Think on..... I think it perverse to include the small mown grass area but then exclude the overgrown pond area east of The Poplars from the Conservation Area .

Clearance here would reinstate dramatic long views southwards from this public walkway viewpoint and enormously add to the overall experience and historic scope and setting of the Green. P40 Do you really mean URBAN design?

East End Green Conservation Area - Draft Appraisal

Thank you for preparing this comprehensive and worthwhile document, and for introducing it to the residents last week.

I wish to object to the proposal to reduce the area of the Conservation Area at the eastern end of the Green, where the Parish Council ownership deed, copy attached, indicates a wide swathe extension of the formal Green, from the residential boundary of 'The Poplars' across to the junction of the RUPP with FP 3A.

Historically this was the site of the farmstead that predated the present East End Green Farm, and indicated on the Griffin 1732 map, but long since destroyed. The area now comprises two shallow ponds but is completely innaccessible and clogged with fallen and dead trees which obscure the remains of the veteran hedgerow which delineates the village Green southern boundary.

From 1975 I recall this as an open wetland wildlife area, very much part of the Green, and from which there were long open southward views across the valley to the far side of the River Lea. My neighbour at 'The Poplars' confirms this open view still existed untill the late 1990's, since when there has been no maintainence, excepting to regularly mow an

isolated patch of grass next to her home, that bears no relevance to the extent and actual boundary of the formal green, and thereby resulting in the current appearance of dereliction to this part of the Conservation Area within the public domain, and where footpath walkers first reach sight of the green.

Your Section 8.15. Schedule of Enhancement Proposals, under Other Actions, does indeed propose opening up this area, which would reinstate one of the only two views southwards out from the Green , the other being from FP1, west of 'The Cottage', and, untill recent vandallistic landraising new higher contours with lucrative rubbish, historic long views of village church spires would still exist.


I understand your Council currently does have funds, and particularly for environmental improvements, and where projects are too expensive for normal Parish Council maintainence issues, so please try to look beyond the present appearance of this neglected land that should be returned to the important contribution it used to make to the overall setting of this Conservation Area.

Perhaps also worth noting is that historically Lord Cowper had two houses on the adjoining 'oval field' former orchard, some brick footings from which still remain.

I was sorry to learn that HCC Records and Archives refused to supply A4 size historic map copies, particularly of the 1732 Griffin map, which would greatly enhance the document. I will happily lobby the Council on your behalf as we are the people who fund this resource, if required.






