

I refer to the above consultation document and as the resident of the following observations:

#### Para 2.9 Works to Trees

The document says it identifies only the most significant trees or groups of trees etc. but my garden is subject to both the Conservation Area and Group TPOs and the document does not identify any such trees. This reinforces my view that the TPO has become a redundant document and should be revoked. Given that the TPO is over 35 years old and has not been updated I would again question its usefulness. It is extraordinary to me that you continue to refer to this TPO to control tree management when you do not know what it covers. Please provide an explanation for perpetuating this situation, thank you.

Also, local historians tell me that the property was never the old Vicarage.

#### Para 8.1 (b)

I note that the intention to extend the Conservation Area to cover the whole of my rear garden rather than the section currently covered. Why is this and what does "to rationalise the boundary" mean? I already have a TPO for this area although EHC do not know what trees are covered by it so what is the benefit of revising the Conservation Area.

Generally, the document does little to address my concerns regarding the Conservation Area/TPO impact on me and my property. I have written to EHC about this without satisfactory response pointing out that my unique situation amounts to discrimination by EHC. This Consultation document does not address these concerns.

#### Para 8.1 (d)

I believe that more of Downfield Road should be included in the Conservation Area - probably not as much as in the earlier version of the Conservation Area but more than currently proposed. The properties are of local interest.

Dear Sir/Madam

I'm aware of proposed changes to the conservation area at Hertford Heath – by excluding properties in Downfield Road. There must be a reason for this change. However, this reason seems not to have been declared – so we must fear that major housing development (at Amwell Farm) is being discussed.

I believe that this change should not take place, as it would start the creeping end to the destruction of what is a beautiful and quintessentially Hertfordshire village. If the council needs to find sites for housing, it should look harder at the many brownfield sites in the area – instead of plundering green and open spaces.

The heart of the village is its green, which fronts directly onto Downfield Road. The former will be spoiled by significant changes to the latter – and Hertford Heath as a village will be ruined by carbuncle developments. Local residents (also taxpayers and voters) will not forgive any attempt to turn Hertford Heath into a London Borough.
