"Following 2 years of hosting peaceful and successful events at Walkern Hall using Temporary Events Notices, Campo Sancho seek to apply for a 5 year time limited premises license to host Campo Sancho on the last weekend of July each year comencing this year on the 27th July 2018. Each year the event will start on Friday and end on the Sunday. Campo Sancho wish to launch this year with a capacity of 750 persons including staff and increase capacity each year by an increment of 100 persons so by 2022 the capacity will be 1150 persons including staff. Campo Sancho will be based in 3 fields very close to Walkern Hall. One field for parking, One field for guest camping and one field for entertainment. The entertainment field is a secluded, lower level field, surrounded by trees, woodland a barbed wire fence and farm fields. The site is not visible from the road and benefits from an emergency access vehicle track through the woods and to the road with excellent drainage throughout."

A comprehensive Event Management Plan has been created over the last 2 years, reviewed after each event and developed with our partners and the local police and East Herts environmental departments to improve and enhance the experience for our guests. The EMP and our other policies will be sent to the Licensing Authority for general circulation.

**b) The prevention of crime and disorder**

Campo Sancho will have a zero tolerance drugs policy  
Campo Sancho will have a strict search policy and confiscation policy  
Campo Sancho have developed systems over the previous 2 events and have created a comprehensive operations plan which covers Perimeter management, Entrances, campsites stage areas, internal site gates, arena crowd management, and an emergency plan. The Security Plan codified by our security firm Corvus Security will be sent to the Licensing Authority for general circulation.

**c) Public safety**

Campo Sancho will monitor weather conditions on a continual basis. A policy has been devised to react to wind, heavy rain and lightning.  
Campo Sancho will host a no glass site  
Campo Sancho will ensure all site staff will have full training at induction and ongoing over the event.  
Campo Sancho have created a site risk assessment and a fire safety management document including Emergency egress and evacuation plan. The EMP including our other policies will be sent to the Licensing authority for general circulation.

**d) The prevention of public nuisance**

Campo Sancho commissioned a Noise Management Plan from F1 Acoustic Co Ltd for the previous event and updated in advance of this years event (pending granting of a license).  
The noise management plan will be sent to the licening authority for general circulation.
