The shared service is known as the CCTV Partnership.

Issues around meetings of the Partnership
- no meetings of officer management board for 2 years.

- joint cctv partnership had not met annually, as required by partnership agreement
- -urgent need for a governance review was agree by the Joint CCTV Executive Board.

July - Governance review was commissioned and completed by August 2018.

Officers began to work on recommendations.

To enable completion

- CCTV management board held meetings every 6 weeks.

Joint CCTV Executive Board increased meeting arrangements from annually to quarterly for the foreseeable future.

Recommendations

- -schedule of recharges produced and is being considered by management board.
- -both cctv partnership and partnership company take a longer term view and draw up a 5 year budget and business plan. Due end March 2019

CCTV arrangements also reviewed - cameras needing renewal as out of date , upgrade etc

Work to commence 2019/2020 using resources held within Housing and Health and \$106 monies.

Work on track to produce a report of the cctv review by March 2019. This will inform the future direction of the service, in conjunction with the governance review of cctv partnership.

Last meeting in January 2019

Next governance steps to be considered.

-members need to consider best form function for cctv partnership and whether partners were getting best value for money.

Officer board had suggested looking at whether current trading standards should continue.

CCTV partnership had been set up with prime intention of protecting residents and so may necessitate more expense

There was agreement that it was important to establish the best most cost effective mechanism for the partnership.

Deadline for SIAS recommendations 'to review the governance framework for the CCTV partnership and confirm it as being fit for purpose 'was extended to 31st May to allow partner members a)to consider at meeting in April the legal review of partnership and trading options commissioned by officers.

Here is a summary of some of the topics discussed during 2018 to 2019.

<u>Sport, Health and Exercise at the University of Hertfordshire.</u>

Professor Elizabeth Pike, Head of Sport, Health and Exercise at the University of Hertfordshire, gave an overview of the University's Sports and Active Lifestyles Strategy, the work of the Sport, Health and Exercise academic department, the sports students' learning and work experiences, and sport-related research and consultancy activities.

The University is seeking opportunities to place students for their compulsory work experience.

Herts Year of Culture 2020 & the Culture Strategy:

Hertfordshire does not currently have a cultural strategy, and the Year of Culture 2020 will identify priorities and inform what is needed. The strategy will be one of the outcomes of the Year of Culture.

Following on from the Hertfordshire Year of Physical Activity in 2018, Hertfordshire's Year of Culture 2020 (YOC2020) will promote current activity and bring cultural providers together to raise wellbeing and participation across the county.

The year of culture will run from January 2020 to December 2020. The aim is to get different organisations working together, raise wellbeing, a sense of belonging in creating communities, and skills development.

40 organisations have been meeting monthly since January and come up with ambition: To showcase Hertfordshire creative and cultural opportunity.

The objectives are purposefully broad so they can fit in with anyone who wants to use the year of culture.

They are looking for interesting activities around the county. If you're already offering things the suggestion is to carry on doing them, but think about if you can you add a 'special theme.

Ambition and 5 broad objectives:

<u>Ambition:</u> to showcase Hertfordshire as a county of creative and cultural opportunity

- Celebrate, share and explore Hertfordshire's arts, culture and heritage
- Enable access and participation in arts, culture and heritage for new audiences
- Increase wellbeing and a sense of belonging through arts, culture and heritage
- **Showcasing pathways** to education, employability and enterprise in the creative and cultural industries in Hertfordshire
- Create new partnerships and new work through skill sharing and new ways of working together

There are already 2,000 organisations doing cultural activities across the County.

'Wow events' are events that stand out in the Year of Culture program. Looking for events that make Hertfordshire stand out as a place for these events.

The Year of Culture will have the input of HACO. Within HACO there are 9 organisations that form this project group.

All 10 district and boroughs have a senior officer/member champion for the Year of Culture.

With the increase of our aging population, there is a focus on non-clinical solutions, such as lifestyle. Aim to reduce use of services, reduce isolation - 7 localities. Partnership approach. Avoid unnecessary readmissions and GP appointments. Referrals from GPs for non-clinical appointments. Work with Home care services. 14,000 interventions - Baseline was c 900 cases pcm In six months, raised this to 1,200 cases pcm using additional resources and better partnership work Need to sustain this at c1,200 cases pcm Annual target is 14,000

Cataloguing Hertfordshire Sculptures Project - Public Monuments and Sculpture Association

They are currently looking for volunteers to help with researching sculptures in region through internet searches and photographing monuments. There is no limit on the number of volunteers they are looking for. The project would finish in May 2020.

Herts Year of Physical Activity 18 moving to YOPA Legacy. There are 2 key things that have counted towards the success of the year: drive of sports partnership and building on successful existing initiatives. The whole year set up on several initiatives that went

further than anticipated. It was vital to get messages out to individuals across the county. This was done through the 'movers and shakers' which included GP's, head teachers, councillors, chief execs etc.

The aims of the year were:

- Increase physical activity levels
- Shift stubborn inactivity levels
- Celebrate what's already happening
- Encourage new programs and events

The Hertfordshire Waste Service - Future Direction

Members of the Hertfordshire Waste Partnership agreed that officers be tasked with putting together a framework plan setting out what the service could look like in 5 years' time, and then working backwards from that point, understand what changes had to take place and thus in the process define key elements of a plan for further consideration.

Along with social care costs, waste is often cited by local authorities as one of the top spending pressures. Therefore the need to realise significant efficiencies and savings is more pressing than ever and the following are being reviewed:

- Brexit, Circular Economy and Targets
- A Vision The Hertfordshire Waste Service
- Service Consistency
- The Hertfordshire Waste Management Service

Resources and Waste Strategy Consultations

Officers and members have over a period of months been actively involved in and preparing to submit responses to government both as a Hertfordshire Waste Service and Local Authority. There has been a number of workshops on this.

Taken together the proposals detailed in the consultations represent the most far reaching and radical shake up of the resources and waste sector since the Environmental Protection Act 1990.

Consequently the Government have indicated an intention to run a second round of consultations which to a large extent will be informed by responses to the first round. Timing for the second round is likely to be either towards the end of 2019 or more likely in early 2020. Consultations were completed on:

- Consistency in household and business recycling collections
- Deposit Return Scheme
- Reforming the UK packaging producer responsibility system
- Plastic packaging tax

Historic England - Heritage Champion

Purpose:

A Heritage Champion's role can be very wide and varied but at its core is being a voice for heritage locally. The champion represents local views on heritage within the authority, can help influence planning decisions and support the local historic environment services (both archaeological and historic buildings conservation officers). Champions can make sure that local plans and strategies capture the contribution that the local historic environment can make to the success of an area. It is up to each Heritage Champion to interpret the role in a way that fits with the Champion's own interests and position, along with local conditions.

Quite apart from being the excuse to fill bookshelves at home with fine picture book volumes and, not subject to GDPR storage rules, to live amid piles of back volumes of the famous English Heritages' 'Conservation Bulletin' magazines the role both informs and enables.

I take information into Committees and also into several other 'outside bodies' and bring to East Herts information and

understanding from Hertfordshire Building Preservation Trust, Beds and Herts Historic Chambers Trust and so on. Two particular 'applications' of the East Herts "Champion of the Historic Built Environment" currently, are through membership of the gathering of other Champions in connection with the Wellbeing Strategy of the Council. The quality of place, and environment often plays a very significant role in a person's sense of 'wellbeing'.

The second particularly important job for the person in the Heritage Champion role is the connection with some of the new homes provision within East Herts. Master planning can be influenced beneficially particularly at the larger sites which are to incorporate or impinge upon historic communities at, for example, North of Ware, and Hunsdon, Gilston and Eastwick.

The important training sessions are booked for me in this civic year. On February 28th I travel to Ely for the Heritage Lottery Fund Council. On March 12th I attend a large central conference at St Martins in the Fields.
