- They were originally under the excuse of 'raising money for charity'. We were always sceptical of this and have seen no evidence/data of actual monies donated to charities. A percentage of money donated per person attending each event should be made available.
- The Festival site is quite ugly and can be seen from different locations along the Walkern Road people camp overnight, there's a massive car-park and crowds of people.
- The noise is awful, especially if the wind is blowing in our direction, thumping repetitive music until late into the night.
- We have to sleep with our bedroom windows closed on warm summer nights to try to shut out the noise coming from the 'Festivals'.
- We have had to go away for the weekend when we know a Festival is taking place or avoid having a garden party/friends over on the same weekend as one of the Festivals.
- People wander along Walkern Road, looking for the Festival site. We've had people knocking on our front door, asking us if we know where Wilkestock is. We have worried about the vulnerability of our property and put our outside garden furniture away on occasions.
- This is a rural area there are no street lights and no pavements. It is a safety concern that event/festival goers are wandering along unlit streets after dark. Seeing the litter evidence of alcohol cans/bottles and empty nitrous oxide canisters along the lanes during and following events these event/festival goers are probably drunk/high when walking to/from the events and this exacerbates the danger to them and also to vehicles driving along the lanes.
- The litter along the lanes and Walkern Road is atrocious walking our dogs around Festival time we've spotted and collected in bin bags, various items of litter, drinks cans, crisp packet wrappers, bottles etc the increase in litter is clear after a Waterbridge event. This was despite the Wilkes' reassurance that people were employed to clear up local litter after the events. They clearly did not do a very good job, if at all.
- We have also witnessed the scattering of hundreds of empty/used nitrous oxide canisters along the edge of the roads/lanes following a Waterbridge event. We've taken photos of these and sent them to Environmental Health along with our objections.
- There's always an increased amount of traffic travelling to/from the site in Walkern Road and High Elms Lane.
- We do not need an events site here in Watton at Stone/Aston. There is already another local site, much more suitably located, at Knebworth House, Stevenage. This is a venue for Festivals, concerts, open air cinemas etc. It is away from local housing so doesn't disturb neighbours/residents and it is situated adjacent to the A1. Much easier and safer for people to travel to/attend without disturbing local residents.

Since an initial one-off charitable festival, events at Waterbridge have since then grown into a commercial operation quite unsuitable for a residential location.

At events at the site, including but not listed to Wilkestock, there is a significant noise nuisance way into the early hours. This is in part due to the excessive volume of music, so loud that individual lyrics are very clearly audible. Even in the period prior to events there is disturbance from sound checks or similar at the site. Despite the distance between our properties, we are unable to sleep in our bedroom throughout the events and are forced to move to another part of the house. Even during the daylight hours our ability to peaceful enjoy the amenity of our garden is impacted by noise from the festivals.

We are also disturbed and woken by groups of festival-goers wandering loudly along Walkern Road at all hours. The litter left behind along the road indicates that alcohol and substance abuse is involved too. Broken alcohol bottles on the verges and roadside constitute a further hazard to vehicles, pedestrians and equestrian users of the country lanes.

This is all very, very different from the tranquillity of non-festival nights in this rural setting. We understand that there are supposed to be vehicular and pedestrian patrols around the site but we have not seen any evidence of these. Nor have we seen any evidence of litter clearing, with litter persisting long after the festivals end.

An unacceptable risk to local residents, visiting festival-goers and other road users alike arises from the vastly increased number of vehicle movements along very narrow country vehicles leading to and from the venue, which are also used by heavy farm machinery, of which the festival visitors may have little experience thus compounding personal and highway safety. There are many blind bends, sudden narrowings and obscured entrances to properties including our own - not such an issue on typically quiet weekends, but a risk factor when traffic is substantially increased. We also frequently see and hear near misses between vehicles on Walkern Road during events which appears to be directly attributable to the increased volume of vehicles visiting the festival site. There is also an increase in commercial traffic delivering goods and services to and from the site before and after the events which again is a concern for public safety on the narrow highways.

We are also concerned with the ability of a residential property to adequately manage the health and safety of the numbers of attendees the festivals attract. The festival site sits within an environment agency flood plain for the River Beane which is also used for water abstraction for public drinking water with the pumping station a short distance from the site. There is therefore the potential for spills of human waste or other contaminants associated with the operation of the festival to enter the water table and to pollute the river.





However, in 2012, the application for a licence was made which doubled the numbers attending each event; quadrupled the numbers of attendees annually; and brought about a six-fold increase in the number of festival nights. We (along with many others) raised our objections with the Licensing Committee when the application was made for this significant escalation. Despite the unsuitability of the site the licence was granted.

As a result of this extension, Hoggsozzle was instituted and ran over the entire May Bank holiday. Mr Wilkes sought to justify this event to me, at least, as a quasi-charitable event where the profits made were used to defer the costs of Wilkestock so allowing more money to go to charity. At this time I was assured by Mr Wilkes that there would be no further events.

Then the mid-summer event Back of Beyond was added. Apart from being contrary to Mr Wilkes assurance of no further events this is a full scale, raw, commercial event.

I wrote to the Licensing Committee at the time and summed up the dangers and difficulties thus

Traffic - I understand Frogmore Hill was closed which meant a very great deal of the traffic entering and leaving the site travelled down the Walkern Road. It was ridiculously busy, and so dangerous, as the road is simply not fit for this volume of traffic. We are particulary aware of this as there is a 'pinch point' directly outside our house. It was plainly dangerous for attendees making their way on foot as there are no pavements and site lines are often very poor (I will not walk my dog up or down the road even on a normal day for these reasons). Also, sign-posting must have been inadequate as a good number of vehicles cut through the single track, private drive of Frogmore Hall from the A602 to the Walkern Road and so past the front of our house. [One of the reasons this site is unsuitable is that it has no reasonable access to public transport which is why so many attendees must walk or drive.]

Rubbish - festival goers left a variety of rubbish along the road : glass bottles, cans, crisp packets, sandwich boxes, plastic bottles but most disturbingly, drug paraphenalia including helium canisters and the ballons used to inhale this (we saw a number of revelers inhaling as they passed our house). I am particularly concerned about broken glass and of course if wildlife (or my dog) got hold of these latter items, it could be fatal.

Noise - particularly when the wind comes from the North West, I find it very difficult to believe noise levels were within proscribed limts at all times (I presume they are monitored during the event?). As crude as my noise meter may be it registered levels over 100dcb at times during Saturday afternoon. Overall, the continuous beat throughout the weekend and early into the mornings is extremely disturbing and tiring.

My daughter whose bedroom is adjacent to the road was kept awake by walkers leaving the event making a very great deal of noise <u>from 2am to 3:30am</u> approximately on Sunday morning (despite her being deaf in one ear!)

In summation, I regard the Waterbridge site as being quite unsuitable for these events. They are disturbing to local residents and dangerous both to residents and attendees. There are much more suitable venues where sound, traffic and transport concerns would make so much less of an impact on local residents and provide much greater levels of convenience and safety to attendees. It is my understanding that I am certainly not the only local resident to feel this way and to have raised objections to events.

My concerns are:

The roads running from the outskirts of Watton at Stone to the festival fields are unlit (or poorly lit) with large stretches that have no curb or footpath. This is forcing the festival attendees on foot to walk in the middle of the roads, sometimes three or four abreast. The roads are also quite winding with poor visibility for the drivers at the curves or inclines. I am concerned that there will be an increased risk of accidents relating to the increased numbers of pedestrians walking in the roads due to the festivals especially if these pedestrians have chosen to walk not drive because they are either drinking alcohol or high.

The festival goers who are walking to the event or driving along the Walkern Road appear to be disposing of rubbish including glass bottles, beer cans, crisp packets, plastic water bottles and in some cases drug paraphernalia in the bushes lining these roads. Our community is made up of a mix of age groups including family groups with children. I am concerned that festival attendees may throw their litter into gardens as well as along the roadside all the way along the Walkern Road from Watton to the festival fields causing risk of injury to children and/or pets from broken glass etc.

At the end of the last festival I went out several times with a black bin liner and gloves and collected as much litter as I could from the roads around my house.

With the large increase of attendees from outside of the local area attending we are concerned about our own security. We do not want an increased amount of people walking across our front lawn because they are getting lost on the way to the event.

The noise from the festivals held in the warmer months is becoming increasingly annoying. This is because we have our windows and patio doors open when it is warm and can hear the music constantly. Originally when we moved in we spoke to local people and they gave us the impression that there was a music event held once a year and this was a charitable event in memory of a family member who had sadly passed.

We respectfully decided not to complain and we still feel that we are happy to turn a blind eye and ear to one charitable event raising money and awareness for a good cause. However, we have since learnt that recently this is not always the case. That some events are now being run by different names - HogSozzle, BOB FSTVL and appear to be held for private profitable reasons. In this case I object to the ever increasing frequency and size of the events.

I object strongly to this getting out of hand and can foresee that someone could get injured or killed on the roads or a child in one of the houses locally hurt by the discarded broken glass or worse by coming into contact with the discarded items relating to drug use.
