NOT RECOMMENDED as the underspend will be more challenging to reallocate to outdoor projects during the winter months and will severely limit how it can be spent in line with the funder's requirements and our own objectives. There will be no opportunity to carry over any underspend into 2026/27.

NOT RECOMMENDED as the projects covered in this report have arisen from much decision between East Herts, various town councils and other partners, such as Hertfordshire Futures, and thus represent a multi-agency view of the economic development needs that can best be addressed with the resources available.
